Mr. Cole was appointed Controller for TC PipeLines GP, Inc. in July 2019. In this role, Mr. Cole is responsible for the accounting and financial reporting functions of the Partnership and its related subsidiary investments. He also holds the role of Director, U.S. Accounting for TC Energy where he similarly leads the accounting and financial reporting group and supports the commercial, compliance and regulatory functions for all U.S. based natural gas pipeline companies.

Before joining TC Energy, Mr. Cole spent more than 20 years in progressively senior accounting and financial leadership roles within the energy industry, including natural gas pipeline companies in public accounting with PricewaterhouseCoopers and Spectra Energy. Mr. Cole held various positions with Spectra Energy, including Corporate Controller and Head of Credit and Enterprise Risk Management. In the latter role, Mr. Cole reported to the Treasurer and provided oversight on credit matters during a multibillion capital program and enterprise risk management matters related to operations, regulatory, strategy, legal and finance. During his time at Spectra Energy, Mr. Cole was also appointed to lead a CFO special project team to help build and enhance the organization's finance culture for professionals in the U.S. and Canada.

Most recently, Mr. Cole held the position of Chief Accounting Officer for Talos Energy, where he co-lead business combination efforts to transform Talos Energy from a private to a public company via a reverse merger.

Mr. Cole holds a Bachelor's degree in Accounting and an MBA from the University of St. Thomas, and he is a Certified Public Accountant in Texas. He is also the founding member of the University of St. Thomas Business School Alumni Board, a volunteer at The First Tee, a youth leadership and character development organization, and serves on the Board of The Women's Resource, an organization to help women make choices toward becoming independent, productive and financially stable.
